**NOTICE OF A
PUBLIC HEARING

Pursuant to Chapter 551, Title 5 of the Texas Government Code and Texas Open Meetings Act, notice is hereby given that the City of Donna, Texas will hold public hearings at City Hall located at 307 S. 12th Street on Wednesday, **August 27, 2014 at 10:00 am and 5:30 pm** for the purpose of discussing the following items:

I. Open public hearing.

- **Public Hearing to solicit public comments from interested parties on the City's proposed annexation proceedings to extend the boundary limits of the City of Donna to include the following described territory, to-wit:**

**DESCRIPTION OF 15.29 ACRES OF LAND
OUT OF LOT 2, BLOCK 4 AND OUT OF LOT 2, BLOCK 8
LA DONNA PLAT SUBDIVISION
HIDALGO COUNTY, TEXAS**

Being 15.29 acres of land situated in Hidalgo County, Texas, and being out of Lot 2, Block 4 and out of Lot 2, Block 8, La Donna Plat Subdivision as per map recorded in Volume I, Page 51 of the Hidalgo, County Map Records, and said 15.29 acre tract being more particularly described by metes and bounds as follows:

BEGINNING at a point located on the north right of way line of Stites Road and hears North 00°02' . East, 20.00 feet and South 89°58' East 20.00 feet from the southwest comer of said Lot 2, Block 4;

THENCE, South 89°58' East, 970.00 feet, with the north right of way line of said Stites Road and along the existing city limits line to a point for the northeast comer of said tract herein described;

THENCE, South 00°02' West, with a line that is parallel to the west line of said Lot 2, at a distance of 20.00 feet pass the common line of said Blocks 4 and 8, and continuing for a total distance of 1350.00 feet to a Point for the southeast comer of said tract herein described;

THENCE, North 89°58' West, 330.00 feet, with the south line of said Lot 2, Block 8 to a point for the most southerly southwest comer of said tract herein described;

THENCE, North 00°02' East, 990.00 feet, with a line that is parallel to the west line of said Lot 2. Block 8 to a point for an inner comer hereof;

THENCE, North 89°58' West, 640.00 feet to a point for the most westerly southwest corner of said tract herein described;

THENCE, North 00°02' East, with the east right of way line of Soderquist Road, at a distance of 330.00 feet pass the common line of said Blocks 4 and 8, and continuing for a total distance of 350.00 feet to the POINT OF BEGINNING and containing 15.29 acres of land more or less.

II. Adjourn.
