The proposed tax rate is greater than the no-new-revenue tax rate. This means that City of Donna is proposing to increase property taxes for the 2022 tax year.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, City of Donna is not required to hold an election at which voters may accept or reject the proposed tax rate.
